Tobacco, Beer, and Alcohol FAQs A beer permit allows a retailer to sell beer and light wine at his licensed premises. For beer and light wine, this permit can be for on-premises or off-premise sales. A municipality or county (depending on where the retailer is located) may issue a local beer permit.

Alcohol Beverage Control - Idaho State Police Idaho State law does not permit an unlicensed person to allow their wine or beer to be consumed by the general public in such contests, competitions or exhibitions. If you intend to compete in a homemaker's contest, competition or exhibition you must obtain the proper state, county, city and federal licensing.
